

Memorandum of Understanding

Each shall be referred to in this MOU individually as "Party" or collectively as "Parties".


A. Objective

The primary objective of this MOU is to enable the parties to identify mutual collaboration opportunities to implement the UGC Scheme – PARAMARSH. The Mentor Institute, Kirori Mal College, University of Delhi will assist NAAC Accreditation aspiring institute – Bansur College, Bypass Road, Bansur (Alwar), Rajasthan -301402 to upgrade its academic performance and get accredited.

B. Areas of Collaboration

Bansur College, Bypass Road, Bansur (Alwar), Rajasthan -301402 and Kirori Mal College, University of Delhi will collaborate in any/all of the following proposed areas:

- Sharing of knowledge, information and resources.

- Bring about enhancement in the overall quality of the mentee institution
- Enhance the profile of institution as a result of improved quality.
- Receive support in the professional development of academics.
- Increased exposure and speedier adaptation to the best practices.






A. General Provisions


1. The parties agree that they shall use their best endeavours to execute the provisions of this MOU. As such, this MOU is non-binding in nature and can't be legally pursued.
2. None of these provisions of this MOU shall be deemed to constitute a partnership between the parties here to and no party shall have any authority to bind or shall be deemed to be agent to the other in any manner. A detailed implementation plan may be drawn up annually by both the parties under this Agreement.
3. This MOU shall become effective on and from the date of execution hereof and shall continue to be effective for two years. After this period, it may be extended by the parties based on mutual agreement in writing until it is rescinded. This MOU may be terminated by either party by issuing a one month prior written notice at any time during the validity of this MOU to the other party.
4. The MOU shall be revisited as and when needed by both the parties with a view to the scope of the same.
5. The Bansur College, Bypass Road, Bansur (Alwar), Rajasthan -301402 will not have financial obligation.
